Waiver and Release of Liability

Express assumption of risk: I, the undersigned, am aware that there are significant risks involved in all aspects of physical training. These risks include, but are not limited to: falls which can result in serious injuries or death; injury or death due to negligence on the part of my child, their training partner, or other people around them; injury or death due to improper use or failure of equipment; strains and sprains. I am aware that any of these above mentioned risks may result in serious injury or death to my child and/or their partner(s). I willingly assume full responsibility for the risks that I am exposing my child to and accept full responsibility for any injury or death that may result from participation in any activity or class while at, or under direction of CrossFit Huntsville.

I acknowledge that my child has no physical impairments, injuries, or illnesses that will endanger themselves or others.

Release: In consideration of the above mentioned risks and hazards and in consideration of the fact that I am willingly and voluntarily allowing my child to participate in the activities offered by CrossFit Huntsville, I, the undersigned, hereby release CrossFit Huntsville, their principals, agents, employees, and volunteers, from any and all liability, claims, demands, actions or rights of action, which are related to, arise out of, or are in any way connected with my child's participation in this activity, including those allegedly attributed to the negligent acts of omissions of the above mentioned parties. This agreement shall be binding upon me, my successors, representatives, heirs, executors, assigns, or transferees. If any portion of this agreement is held invalid, I agree that the remainder of the agreement shall remain in full legal force and effect.

If I am signing on behalf of a minor child, I also give full permissions for any person connected with CrossFit Huntsville to administer first aid if deemed necessary, and in case of serious illness or injury, I give permission to call for medical and/or surgical care for the child and to transport the child to a medical facility deemed necessary for the well being of the child.

Indemnification: The parent of the participant recognizes that there is risk involved in the types of activities offered by CrossFit Huntsville. Therefore the parent of the participant accepts financial responsibility for any injury that the participant may cause either to him/herself or to any other participant due to his/her negligence. Should the above mentioned parties, or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to reimburse them for such fees and costs. I further agree to indemnify and hold harmless CrossFit Huntsville, their principals, agents, employees, and volunteers from liability for the injury or death of any person(s) and damage to property that may result from my negligent or intentional act or omission while participating in activities offered by CrossFit Huntsville, at the main building or abroad. This includes but is not limited to parks, recreational areas, playgrounds, areas adjacent to main building, and/or any area selected for training by CrossFit Huntsville.
